This is a contract between Kuddle Kennels and the pet owner whose signature appears below (hereinafter called "Owner").

1. Kuddle Kennels hereinafter referred to as the "Kennel", agrees to exercise due and reasonable care to maintain clean and sanitary quarters, to provide food according to the standard care for kennel operators or owners instructions, but does not guarantee immunity against diseases beyond its control.

2. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Kennel. And further agrees to pay all costs and charges for special services requested and all veterinary costs for the pet during the time said pet is in the care of the Kennel. If you do not pick up the animal within five days of the day we agree upon, we may assume the animal is abandoned and you authorize us to dispose of the animal as we see fit. You realize that you are still obligated to pay the full amount of the bill. You also agree to pay a finance charge of 1.5% per month (18% per annum) and any and all collection or attorney's fees incurred by us relating to your non-payment.

3. The Kennel does not assume and shall not be held responsible for any liability with respect the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of the Kennel or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said animal at any time within the term and time of the contract. The responsibility and/or liability of the Kennel, in no event shall exceed the sum of One Hundred Dollars (\$100.00) and the undersigned agrees to limit the responsibility to One Hundred Dollars (\$100.00) for any and all damages sustained or suffered by reason of the boarding of this animal and said Kennel to the sum of One Hundred Dollars (\$100.00) and no more, and agrees not to claim any damages against said Kennel of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum.

Owner hereby agrees to indemnify and hold harmless Kuddle Kennels, its employees, agents, servants, principals, officers, assigns, successors, insurers, partners, affiliates, subsidiaries, parent entities, and related entities (collectively hereinafter "Indemnified Parties") from and against, and to reimburse the Indemnified Parties with respect to, any and all claims, demands, causes of action, losses, damages, liabilities, costs, and expenses (including reasonable attorney's fees and other costs and expenses incident to any claim, suit, action or proceeding) arising out of or resulting from any goods or services rendered as a result of this Contract, or the acts or omissions of Owner or the within named animal.

4. The owner of the within named animal specifically represents that he is the sole owner of said animal and that there is not now any lien or mortgage against said animal.

5. The Kennel shall have, and is hereby granted, a lien on the animal for any and all unpaid boarding and/or other charges resulting from the boarding of said animal with the Kennel.

6. If the animal becomes ill or if the state of the pet's health requires professional attention, Kuddle Kennels, in its sole discretion, may engage the services of a Veterinarian who may administer medicine, and/or dictate a special diet, and/or give other necessary attention to the animal, that said expenses for this services shall be paid by the Owner.

7. Any controversy or claim arising out of or relating to this contract shall be determined by the Court of Common Pleas for the Thirty-Ninth Judicial District-Franklin County Branch.

8. If your pet shows infestation of fleas it will be shampooed and treated, at owner's expense, price is \$50.00 - \$100.00 depending on the size of the pet. Is pet currently using a flea treatment? \_\_\_\_\_

9. When requested, Kuddle Kennels will board more than one pet of the same species, from the same household, in a single kennel; however, Kuddle Kennels reserves the right to place the pets in separate kennels if they deem necessary. The single kennel rate will then apply to each pet.

10. This Contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, and assigns of the owner of the within named animal.
